WORK PROGRESSES ON NEW SUB-STATION

As all can note, work is roaring along on the new hydro sub-station above the tracks just west of Morgan Road. It will serve not only the expanding needs of a rapidly-expanding Baie d'Urfee but also this end of the island. A pat on the back is due our council for having it located on the north side of the highway. Original plans called for it to be on the south side, which would have put quite a crimp into the residential development there, and the general attractiveness of the town. However, by dint of protracted argument and general persuasiveness on the part of council - and the promise to build a short road into the site - Quebec hydro agreed to change its mind. In five years, is the prediction, all the south side will be lovely lots and homes!

SWIMMING IS THE ORDER OF THE DAY AGAIN

With fine weather here and school out, the town's favorite swimming spot is going full blast again. Under the direction of Recreation Chairman Frank Booth, Bill Norcott has lined up a lifeguard and assistant, the beach has received some ten trucks of new sand, and enthusiastic Baie d'Urfite volunteers have repainted and launched the diving rafts, and put in the dock.

Tom Dunphy has been engaged as lifeguard and D'Arcy Little will assist on weekends when required.

In a note introducing Mr. Dunphy, Mr. Norcott says:

Dear Citizen:

May I take this opportunity to introduce to you Mr. Tom Dunphy who will act as Life Guard at the Town Hall beach this Summer.

Mr. Dunphy is well qualified for the position and has just completed a refresher course in Water Safety under the auspices of the Canadian Red Cross Society.

He will be on duty from 9:30 a. m. to 12:30 p. m. and from 1:30 p. m. until 6:00 p. m. daily except Wednesday. His employment will commence on July 1, 1954 and end on September 1, 1954.

It is hoped that much of Mr. Dunphy's time will be spent in training

our Teen-agers in Water Safety so that we may, in the future, develop our own life guard group.

Please read the following rules of Water Safety. They apply to both adults and children. Please read them and explain them to your children. Let us give Mr. Dunphy our co-operation so that we may enjoy ourselves to the fullest.

If you have any suggestions to improve our facilities, kindly get in touch with me.

WATER SAFETY RULES

(Rules apply to children and adults)

- 1. Positively no swimming alone (choose a friend to swim with for fun and for safety).
- 2. Non-swimmers must remain in the boomed area.
- 3. Swimmers must not swim from shallow area to deep area by swimming under booms or vice versa.
- 4. No diving from dock or swimming under the dock.
- 5. Pushing, throwing, or general fooling is prohibited on the rafts.
- 6. Swimmers should swim and dive in the area between the rafts and the booms for maximum safety.
- 7. No swimming under rafts.
- 8. No boats to be permitted in swimming areas.
- 9. Swimming should not be attempted for at least 1 1/2 to 2 hours after meals.
- 10. Absolutely no swimming after dark.
- 11. No dogs on beach, wharf or rafts.
- 12. No bicycles on beach.
- 13. Adults may swim after 6:00 p. m. if accompanied by a friend.

OUR JUICE DIDN'T KILL 'EM, DECLARES HYDRO

When game warden Harry Clarson protested that in some peculiar fashion hundreds of fish were being found dead in one particular spot, where hydro cables entered the water, the Citizens' Association asked the hydro for an investigation and a report. Following is a letter received:

Baie d'Urfe Citizens' Association, Baie d'Urfe, P. Q.

Dear Sir:

Your letter of May 26th regarding the dead fish washed up on the Baie d'Urfe shore of the Ottawa River in the vicinity of our 120 kv submarine cables, has been referred to me.

When an accumulation of these fish was noticed at Baie d'Urfe earlier in the month the Department of Game and Fisheries of the Province of Quebec started an investigation of the entire area along the shores of the Ottawa River and Lake St. Louis to determine the cause of the dead fish. At the same time our Commission made a thorough check of our 120 kv submarine cables installed in the vicinity and could find no abnormal condition that might have contributed to the death of the fish.

Furthermore, when we contacted the Department of Game and Fisheries today to obtain the result of their investigation, we were informed that dead fish were found not only at the location of our submarine cables, but at 50 other locations along the shores of the Ottawa River and Lake St. Louis. We were also informed that the concentration of these dead fish at Baie d'Urfe may be attributed to a predominance of certain winds at that location during the spring.

The investigation referred to above is being made for the Department of Game and Fisheries by Dr. Gustave Prevost, Director of the Biology Department, University of Montreal.

While we have been assured that our cables are not the cause of the dead fish, we understand that the Department of Game and Fisheries is continuing their study in an attempt to determine the exact cause.

Any further information regarding their investigation can be obtained directly from them.

Last year's show was an outstanding success, do let us make this one even better, pick out your three best pieces of work and send them in.



> TOWN HALL PARTITION, NEW SECTY-TREAS. CHIEF TOPICS AT ASSOCIATION MEETING

Numbering into the 80's - nearly three times normal attendance - citizens packed the town hall at the June meeting of the Baie d'Urfee Citizens' Association principally to discuss partitioning of the town hall and appointment of a new town secretary-treasurer. Three resolutions were passed, two to be brought to the attention of council.

After minutes were read Tom Vauthier requested \$500 be set aside from the Town's regular \$1000 recreation grant to provide a warming hut for the Morgan Park winter rink.

Bill Norcott objected, saying another \$450 was needed to enlarge the swimming beach some 25 feet to the east and to replace sand washed down the river. " The shack can wait," said Norcott. "June is here and we need the beach fixed now". Mr. Vauthier is going to submit plans and specifications for the new hut.

Clarey McGuire suggested it was a question of "how much" should be allotted for Baie d'Urfee's winter and summer recreational facilities. The money shouldn't be given all to one or all to the other but should be divided up.

Chairman Charlie Johnstone said the resolution on how to establish and enforce the 30 m.p.h. speed limit in the Town had been sent to Council and Alderman Corbett, Roads Chairman, was studying the matter.

Herb Brookhouse and his committee were thanked for the very successful Town Auction.

Jack Mitcham, reporting on testing of the lake water for swimming, said Macdonald College won't make regular checks of the bacteria count for publication but he'll try to get one official test before the swimming season.

Jack Mitcham also announced that additional toilet facilities for the town grounds will be installed -- complete with septic tank -- on the west end of the park.

Lars Firing, Treasurer, reported \$371.50 in the bank with \$130 in News & Views advertising still outstanding. Nearly 200 families, perhaps a record number, are now members of the Citizens' Ass'n, and membership fees adequately care for the expenses of a lifeguard for the beach during July and August.

Bill Spriggs reported on negotiations concerning the new grammar school in Baie d'Urfee. He also announced a new ruling that a child must be five before September l in order to enroll in Kindergarten. The date was previously January 1.

Chester Ellis requested volunteers to aid the Home and School Association with its projects the next school year.

Alderman Harry Smythe said that he, plus Will Spriggs and Eric Butler, represent Baie d'Urfee and Senneville on the School Board, and the terms of both Spriggs and Butler are up this year. It was up to the citizens of the two communities to appoint replacements.

On motion of Pat Laird and Pete Smith, Mr. Spriggs was reappointed to represent Baie d'Urfee for another term. The vote was unanimous.

When the matters of the partition and new secretary - treasurer came up, Chairman Johnstone summarized a letter sent by the (it is printed elsewhere in this issue) executive to council. A joint meeting of council and the executive is planned. Alderman Brookhouse has been invited to attend future meetings of the executive. A motion by Jean Ross and Helen Cavell, protesting the partitioning of the town hall and urging removal of the partition, was carried 56-14, after prolonged discussion and a futile motion by R. H. Tivy to defer consideration of the above motion for a month.

Chester Ellis said only two members of council were in on the decision to partition the town hall. Alderman Brookhouse said there was no dissension among other members of council when the decision to partition was announced to them by the council committee in charge of town buildings. It was felt that the town hall was the logical place for the secretary treasurer's office, and from a monetary standpoint it was certainly in the best interests of the town.

Pete Smith pointed out the problems confronting town council, expressed the belief the town's interests were their first consideration, and suggested they be given time to work things out. Ewing Tait said the hall was needed as a meeting place, and Don MacDonald said council gave the Horticultural Society, which counted on use of the town hall, very little consideration. Tom Vauthier suggested that council first appoint a secretary-treasurer, and perhaps the office-space situation would work itself out.

Responding to questions of Harry Dixon, Mr. Brookhouse said council knew of John Long's impending resignation in April and it was in News and Views, together with information that Mr. Grimm had been asked to succeed him, in May. Chester Ellis said the first people knew of Mr. Long quitting was when Mr. Grimm was appointed.

"Well, there's no point talking about it now", said Mr. Brookhouse, "Mr. Grimm has resigned". (He was officially appointed at the June council meeting.)

Mr. Tait, seconded by Doris Cape, moved:

"Resolve that the Baie d'Urfee Citizens' Association recommends that Council follow these principles whenever a vacancy occurs in a public office:

- The vacancy should be given sufficient publicity to attract the attention of most probable candidates by advertising locally and in the City of Montreal.
- 2. No person should be appointed to any position in the municipal organization who might benefit commercially from his appointment or who represents interests which might not always be compatible with the interests of the Town.

"Further, that the Executive of this Association be instructed to bring these recommendations to the notice of the Town Council."

Mr. Tait also stated he felt the Association should emphasize to Council that this resolution does not refer to a particular individual but is a question of principle. Motion carried.

It was moved by Mr. Osborne and seconded by Mr. Duncan that members of the Baie d'Urfee Citizens' Association, having learned with regret of the resignation of John W. Long as Sec.-Treas. of the Town, desire to express their appreciation of the good work he has done and for his friendly and helpful guidance to Council and to many individual citizens.

The motion passed unanimously.
